WHEREAS, Elgin N. Duck

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, known as lot #6, on plat prepared by W. R. Williams, Jr., Surveyor, of property of H. G. Duck Estate, Bates Township, Greenville County, State of South Carolina, dated May 1970, containing 1.48 acres, more or less, and according to said plat, having the following metes and bounds, to-wit:

BEGINNING in center of White Horse Road Ext., and running N. 59-39 W. 125.0 feet to an iron pin; thence N. 42-39 W. 35.0 feet to an iron pin; thence N. 76-39 W. 35.0 feet to an iron pin; thence N. 59-39 W. 408.0 feet to a corner iron pin; thence N. 31-24 E. 108.0 feet to an iron pin joining Lot #5; thence S. 59-39 E. 600.0 feet to center of White Horse Road Ext.; thence along line of said road S. 31-24 W. 108.0 feet to the point of beginning.
