# MORTGAGE

THIS MORTGAGE is made this 21st day of May, 1981, between the Mortgagor, GATEWOOD BUILDERS, INC., (herein "Borrower"), and the Mortgagee, First Federal Savings and Loan Association, a corporation organized and existing under the laws of the United States of America, whose address is 301 College Street, Greenville, South Carolina (herein "Lender").

WHEREAS, Borrower is indebted to Lender in the principal sum of Seventy Thousand Three Hundred and No/100 (\$70,300.00) Dollars, which indebtedness is evidenced by Borrower's note dated May 21, 1981, (herein "Note"), providing for monthly installments of principal and interest, with the balance of the indebtedness, if not sooner paid, due and payable on May 1, 2012.....;

TO SECURE to Lender (a) the repayment of the indebtedness evidenced by the Note, with interest thereon, the payment of all other sums, with interest thereon, advanced in accordance herewith to protect the security of this Mortgage, and the performance of the covenants and agreements of Borrower herein contained, and (b) the repayment of any future advances, with interest thereon, made to Borrower by Lender pursuant to paragraph 21 hereof (herein "Future Advances"), Borrower does hereby mortgage, grant and convey to Lender and Lender's successors and assigns the following described property located in the County of Greenville, State of South Carolina:

ALL that piece, parcel or lot of land situate, lying and being on the Southwestern side of Dawes Drive, near the City of Greenville, in the County of Greenville, State of South Carolina, and known and designated as Lot No. 274 of a Subdivision known as Canebrake, Phase III, plat of which is recorded in the R.M.C. Office for Greenville County in Plat Book 7-X at Page 97, and, according to said plat, has the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Southwestern side of Dawes Drive, at the joint front corner of Lots Nos. 273 and 274, and running thence with the joint line of said Lots S. 71-52 W. 130 feet to an iron pin; running thence N. 18-08 W. 92.31 feet to an iron pin at the joint rear corner of Lots Nos. 274 and 275; running thence with the joint line of said Lots N. 71-52 E. 130 feet to an iron pin on the Southwestern side of Dawes Drive; running thence with the Southwestern side of said Drive S. 18-08 E. 92.31 feet to an iron pin, point of beginning.
