with interest thereon from date at the rate of 12 % per centum per annum, to be paid:

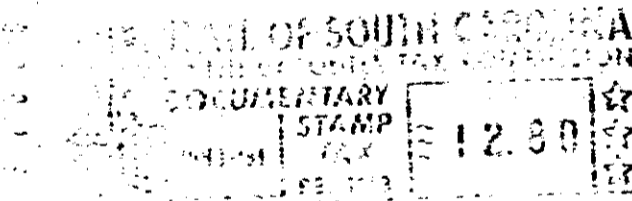

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, at the intersection of Forestdale Drive and Red Cherry Lane, being known and designated as Lot No. 57, Forestdale Heights, as shown on plat thereof prepared by R.
