For and in consideration of the sum of One Dollar (\$1.00), and other good and valuable consideration, to it in hand paid at or before the signing, sealing and delivery of these presents, receipt of which is hereby acknowledged, Blue Ridge PRODUCTION CREDIT ASSOCIATION, a corporation, the owner and holder of a certain mortgage, executed by Horace F. Forrester to it, on June 10, 19 71, recorded in Mortgage Book 1194, page 179, public records of GREENVILLE County, South Carolina, does hereby release and relinquish the lien of said mortgage

insofar, and so far only, as the same covers and embraces the following described property: ALL of that certain piece, parcel or tract of land located in the State of S.C., Gville Co., lying on the western side of Packs(Pax) Mountain Rd. and being shown and designated as 25 acres on a plat of the property of Horace F. Forrester, surveyed for Scott Forrester, dated Mar. 31, 1981, prepared by Lindsey & Assoc., Registered Land Surveyors, recorded in the RMC Office for Gville Co., in Plat Bk. 8-K, Pg. 82, and having, according to said plat, the following courses & distances, to-wit: BEGINNING at a point in the center of Packs Mountain Rd., which point lies approximately 4,250 ft., more or less, in a northwesterly direction from the intersection of Packs Mountain Road & Camp Creek Rd., and which point is the joint front corner of this property and property now or formerly of Elizabeth M. Anthony, and running thence with the common line of this property and Elizabeth M. Anthony, S. 46-00 W. 49-6 ft., thence continuing with the common line of this property and Anthony, S. 70-00 W. 1,231.1 ft. to an iron pin; thence a new line with property of Horace F. Forrester, N. 20-00 W. 929.8 ft.; thence a new line with other property of Horace F.
