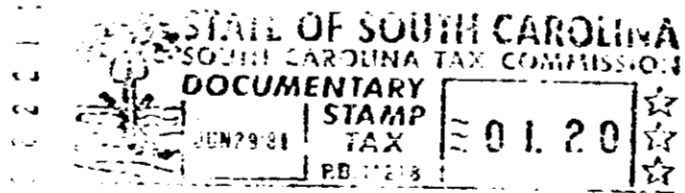

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Gantt Township, on the east side of Grove Road, and further shown on a plat prepared by C. C. Jones and Associates, dated August 31, 1955, and having according to the said plat the following metes and bounds:

Beginning at a point on Grove Road and thence S. 59-45 E. 250 feet to a point; thence S. 30-15 W. 300 feet to a point; thence N. 59-45 W. 250 feet to a point on said Grove Road; thence down Grove Road, N. 30-15 E. 300 feet to the beginning corner.

This is the same property conveyed to the mortgagors herein by the mortgagee, on even date, and recorded in Deed Book 1188, page 743, RMC Office for Greenville County.

The Mortgagor further covenants to warrant and forever defend all and singular the said premises unto the Mortgagee forever, from and against the Mortgagor and all persons whomsoever lawfully claiming the same or any part thereof.
