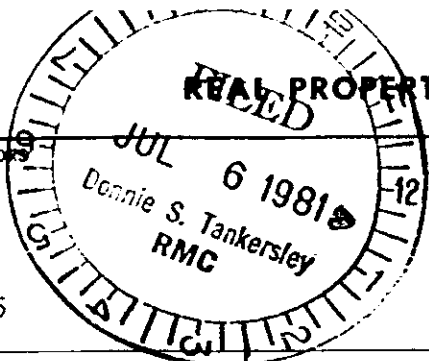

To secure payment of a note which I signed today promising to pay you the above Total of Payments and to secure all my other and future obligations to you, the Maximum Outstanding at any given time not to exceed the amount stated above, each of the undersigned grants, bargains, sells and releases to you the real estate described below and all present and future improvements on the real estate, which is located in South Carolina, County of Greenville

All that certain piece, parcel or lot of land, situate, lying and being on the northwest side of Cammer Avenue, in the City of Greenville, County of Greenville, State of South Carolina, being shown and designated as Lot 19 and the northeast portion of Lot 20 on plat of Augusta Road at Hills recorded in the RMC Office for Greenville County in Plat Book "L" at Pages 56 and 57, and having according to said plat the following metes and bounds, to-wit:

Beginning at an iron pin on the northwest side of Cammer Avenue, 690 feet to from the intersection of Long Hill Street and Cammer Avenue, and running thence N. 47-50 E. 166.3 feet to an iron pin on the line of Property now or formerly of Jenkinson; thence with the Jenkinson property N. 42-07 E. 90 feet to a point, joint rear corner of Lots 18 and 19; thence along the line of Lot 18, S. 47-50 W. 166.35 feet to an iron pin on the northwest side of Cammer Avenue thence along Cammer Avenue S. 42-07 W. 90 feet to the beginning point.

I will pay all expenses you incur in enforcing any security interest, including reasonable attorney's fees as permitted by law.

Each of the undersigned agrees that no extension of time or other variation of any obligation secured by this mortgage will affect any other obligations under this mortgage.

Each of the undersigned waives marital rights, homestead exemption and all other exemptions under South Carolina law.

This mortgage will extend, consolidate and renew any existing mortgage you hold against me on the real estate described above.

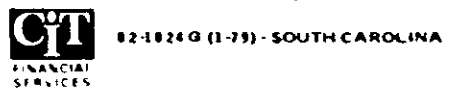
