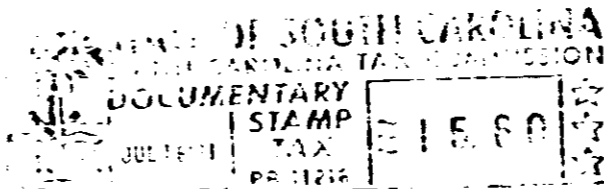
"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville on the East side of Ridgewood Drive, being shown as lot #15 on plat of Woodland Hills, recorded in RMC of said County in Plat-book Y at page 60 and having, according thereto the following metes and bounds, to-wit:

BEGINNING at an iron pin on the eastern side of Ridgewood Drive joint front corner of lots 14 and 15 and running with that line N. 73 E. 160 feet to an iron pin; thence, N. 17 W. 95 feet to an iron pin on Lee Road; thence S. 73 W. 135 feet to an iron pin; thence with the curve of Ridgewood Drive, the chord of which is S. 28 W. 35.3 feet, to an iron pin; thence with said Drive S. 17 E. 70 feet to the point of beginning.

This being the same property conveyed to the mortgagors herein by deed of Mary F. Williams of even date, recorded in the RMC of Greenville County herewith.

This conveyance is subject to all easements, restrictions, covenants or rights of way of record or on the ground.
