"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate. Iving and being in the State of South Carolina. County of Greenville, lying, situate and being in Butler Township being known and designated as Lot No. 9, on a plat of Section 2, of Spring Forest which plat is recorded in the RMC Office for Greenville County, South Carolina in Plat Book "BBB", at Page 34, and as shown on a more recent survey entitled "Property of Colin Bouglas neaton and Janice B. Heaton" prepared by Dalton and Neeves Company, Engineers, which plat is dated October 1973, and recorded in the RMC Office for Greenville County, South Carolina in Plat Book "42", at Page 3d, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Southern side of Old Spartanburg Road joint corner of Lots Ro. 3 and 7 and running thence with the line of Lot Ro. 3, S. 7-23 E. 120.7 feet to a pin in line of Lot Ro. 1); thence with the line of Lot Ro. 10, R. 36-20 w. 143.3 feet to a pin on Butler Springs Road; thence with the Eastern side of said Road, R. 5-27 w. 116.2 feet to a pin; thence with the curve of the intersection of Butler Springs Road with Old Spartanburg Road, the chord of which is R. 43-30 E. 19.9 feet to a pin on Old Spartanburg Road, thence with the Southern side of Said Road, S. 54-33 E. 124.2 feet to the point of beginning.
