To secure payment of a note which I signed today promising to pay you the above Total of Payments and to secure all my other and future obligations to you, the Maximum Outstanding at any given time not to exceed the amount stated above, each of the undersigned grants, bargains, sells and releases to you the real estate described below and all present and future improvements on the real estate, which is located in South Carolina, County of Greenville

ALL that lot of land with improvements on the Northern side of Pine Grove Lane is Greenville County, South Carolina, being shown as Lot No. 25 on a Plat of Pine Grove Heights recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book Y, Page 87, and having according] to said Plat the following metes and bounds, to-wit: BEGINNING at an iron pin on the northern side of Pine Grove Lane at the joint front corners fo Lots Nos. 24 and 25 and running thence N. 25-30 E. 160 Feet to an iron pin; thence S. 64-30 E. 100 feet to an iron pin; thence S. 25-30 W. 160 feet to an iron pin on the northern side of Pine Grove Lane; thence ALong the Northern side of Pine Groce Lane, N. 64-30 w. 100 feet to an iron pin, the point of beginning.

Each of the undersigned waives marital rights, homestead exemption and all other exemptions under South Carolina law.
