This mortgage will extend, consolidate and renew any existing mortgage you hold against me on the real estate described above.

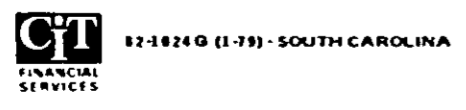
