Greenville ..., State of South Carolina:

All that lot of land with the buildings and improvements thereon situate on the northwest side of Bradley Boulevard in the City of Greenville, in Greenville County, South Carolina, being shown as Lot No. 86 on plat of University Park, recorded in the RMC Office for Greenville County, South Carolina, in plat book P, at page 127, and having, according to said plat the following metes and bounds, to wit:

Beginning at an iron pin on the northwest side of Bradley Boulevard at the joint front corner of Lots 85 and 86 and running thence with the line of lot 85, N. 37-34 W. 211.6 feet to an iron pin on the southeast side of Brookside Circle; thence along Brookside Circle S. 57-38 W. 75.3 feet to an iron pin; thence with the line of Lot 87, S. 37-34 E. 218.6 feet to an iron pin on the orthwest side of Bradley Boudlevard; thence along Bradley Boulevard, N. 52-26 E. 75 feet to the beginning corner.
