ALL that certain piece, parcel, or lots of land, situate, lying and being at the corner of Washington Street and Nash Street (formerly Hunt Street), in the City and County of Greenville, South Carolina, said property being shown as Lots 4 and 5, Block B, Map of EAST PARK, on a Plat of Part of BOYCE LAWN ADDITION to Greenville, S. C., recorded in Plat Book A, at Page 383, and having, according to a more recent survey dated September 8, 1981, prepared by K. T. Gould, Inc., Surveyors, entitled PROPERTY OF WESCO, INC., recorded in the RMC Office for Greenville County in Plat Book 8-7, at Page 37, the following metes and bounds:

BEGINNING at an iron pin at the sidewalk intersection of Washington Street and Nash Street (formerly Hunt Street), and running thence with Nash Street (formerly Hunt Street), S 17-15 E, 150 feet to an iron pin; thence N 72-45 E, 100 feet to an iron pin; thence N 17-15 W, 150 feet to an iron pin on the southern side of the sidewalk fronting on Washington Street; thence with said sidewalk, S 72-45 W, 100 feet to an iron pin, the point of beginning.
