ALL WHOM THESE PRESENTS MAY CONCERN:

WHEREAS, I, NANCY P. STONE, as Trustee for Margaret Christie Stone and Catherine Alexander Stone,

(hereinafter referred to as Mortgagor) is well and truly indebted unto RUTH IRENE HOLCOMBE

(hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of FIVE THOUSAND SEVEN HUNDRED EIGHTY AND NO/100 Dollars (\$ 5,780.00) due and payable

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, containing 3.89 Acres according to a survey of the Property of Irene Holcombe made by T. Craig Keith, Engineer, on June 22, 1981, and having the following metes and bounds:

BEGINNING at a nail and cap in the approximate center of a county road and running thence along said county road S. 27-43 E. 240 feet to a spike; running thence along property of Irene Holcombe S. 37-30 W. 759 feet to an old iron pin; running thence along the line of property now or formerly of Boyce Miller, Jr. N. 14-27 W. 231.3 feet to an iron pin; running thence along property now or formerly of Irene Holcombe N. 76-23 E. 703.9 feet to a nail and cap in the center of a county road, the beginning point.
