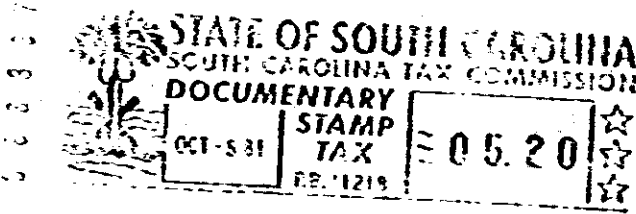
NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being known as Lot No. 142, on a plat of Conestee Village, prepared by R. E. Dalton, Surveyor, dated December, 1943 and recorded in Plat Book K at Page 276, and having such metes and bounds as appear by reference to said plat.

THIS is the identical property conveyed to the Mortgagees by deed of the mortgagor to be recorded of even date herewith and this mortgage is being given to secure a portion of the purchase price of the within described property.

It is agreed that any payment not received within fifteen (15) days of due date shall be subject to a late payment penalty of 4% of the payment.

It is also agreed and understood that this mortgage and the note it secures, shall become immediately due and payable if the subject property is transferred by deed or contract without the prior written consent of Mortgagee.
