WHEREAS,

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the northern side of Don Drive and being shown and designated as Lot No. 283, on a plat of Section B of Gower Estates, prepared by R. K. Campbell, dated December, 1961, and recorded in the R.M.C. Office for Greenville County in Plat Book XX, Pages 36 and 37 and having, according to said plat, the following metes and bounds, to-wit:

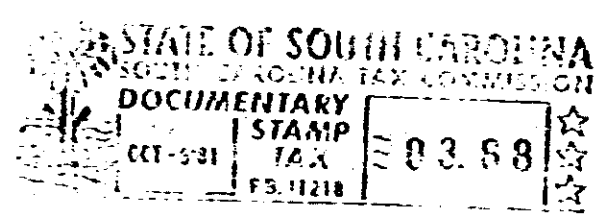
BEGINNING at an iron pin on the northern side of Don Drive at the joint front corner of Lots 282 and 283 and running thence along line of Lot 282, N. 01-32 E., 170.2 feet to an iron pin; thence S. 38-26 E., 100 feet to an iron pin; thence S. 20-57 E., 85.1 feet to an iron pin on the northern side of Don Drive; thence along the northern side of Don Drive S. 82-44 W., 97.9 feet to the beginning corner.

THIS is the same property conveyed to the Mortgagor herein by deed of John R. Steele, dated November 16, 1978, and recorded in the R.M.C. Office for Greenville County in Deed Book 1092, at Page 2.
