WHEREAS, We, HENRY R. MASSEY and MARIE MASSEY,

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the North side of Camp Creek Road, containing 2.11 acres, more or less, [inclusive of road right-of-way in Camp Creek Road] the general location of which is shown on plat entitled "Property of Geneva P. H. Crowe, Surveyed for Henry Massey" which plat was prepared by Lindsey & Associates, April 15, 1981, and is recorded in the RMC Office for Greenville County, S. C. in plat book 8-0, at page 32 and being shown on the Block Book for Greenville County, S. C. as Lot 30, 3, of Block 1, at page 643.1, reference to said plats being craved for a more detailed description.
