

ALL that certain piece, parcel or lot of land, with all improvements thereon, situate, lying and being in the State of South Carolina, County of Greenville, being shown and designated as Lot No. 60 on plat of SPRINGFIELD, recorded in Plat Book 3-B, page 14, in the RMC Office for Greenville County, S. C., and having according to said plat the following metes and bounds, to-wit:
