THIS INDENTURE, made this 26th day of October, in the year One thousand Nine Hundred and Eighty-One, between JESSE C. BELCHER, Trustee P/B/O JOSHUA E. VARAT, Under Trust Agreement dated September 29, 1980, amended May 29, 1981, of Greenville, South Carolina, being hereinafter known and designated as MORTGAGOR, and FIRST NATIONAL BANK OF SOUTH CAROLINA, being hereinafter known and designated as the MORTGAGEE,

W I T N E S S E T H :

NOW, THEREFORE, THIS INDENTURE WITNESSETH, that the Mortgagor, for the better securing the payment of the said Mortgagee of the said sum of money mentioned in said note or obligation, with interest thereon, and also for and in consideration of the sum of ONE (\$1.00) DOLLAR to the Mortgagor in hand paid by the Mortgagee, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, sell and convey unto the Mortgagee, its successors and assigns, forever, all that piece or parcel of land situate, lying and being in the County of Greenville, State of South Carolina, described as follows:
