with interest thereon from date at the rate of 18% per centum per annum, to be paid: monthly

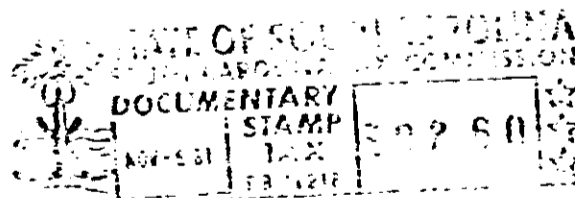

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, containing 2.57 Acres according to a survey of the property of Jerry Albert Lowe made by W. R. William October 27, 1981, and having according to said plat the following courses and distances, to wit:

BEGINNING at a nail and cap in the approximate center of Settlement Road at the joint front corner of property of Gregory and running thence along the approximate center of Settlement Road N. 7-03 W. 125 feet; thence continuing with said road N. 16-11 W. 18.4 feet to a nail and cap; running thence along line of property of Williams N. 73-37 E. a total of 640.8 feet to iron pin; running thence along line now or formerly of Jones S. 22-12 E. 198.3 feet to iron pin; running thence along line of property now or formerly of Gregory N. 78-17 W. a total of 683.6 feet to a nail and cap in Settlement Road, the beginning corner.
