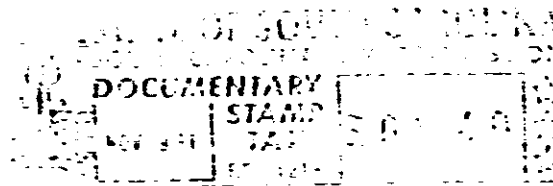
NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

*ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of

ALL those lots of land in the County of Greenville, State of South Carolina, being known and designated as Lots Nos. 11 and 12, Section 3, on Plat of J. M. Fortner property recorded in Plat Book "G", Page 129, of the R.M.C. Office for Greenville County, S. C., and having according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northeast side of Welcome Street, the joint front corner of Lts Nos. 10 and 11; thence with the joint line of said lots N. 57-30 E. 125 feet; thence N. 32-30 W. 100 feet to an iron pin at the corner of Lot No. 13; thence with the line of said street S. 57-30 W. 125 feet to an iron pin on the northeast side of Welcome Street; thence with the northeast side of said street S. 32-30 E. 100 feet to the beginning corner.
