WHEREAS, JANICE S. MORROW AND RONALD L. MORROW

(hereinafter referred to as Mortgagor) is well and truly indebted unto the GREENVILLE COUNTY REDEVELOPMENT AUTHORITY

(hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of Eight Thousand Eight Hundred Fifty-six and No/100
Dollars (\$ 8,856.00) due and payable

in 180 consecutive monthly installments of Sixty-one and 19/100 (\$61.19) Dollars, due and payable on the 15th day of each month, commencing on January 15, 1982,

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is her-by acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of GREENVILLE, being shown as lot 393, section no. 2, plat of Brandon Plant, Abney Mills, recorded in Plat Book QQ at pages 56 through 59, Office of the R.M.C. for Greenville County, said lot fronting on McArthur Street (formerly known as Wilson Street).
