TO ALL WHOM THESE PRESENTS MAY CONCERN:

WHEREAS, PAUL BROCKMAN AND DORIS J. BROCKMAN

(hereinafter referred to as Mortgagor) is well and truly indebted unto the GREENVILLE COUNTY REDEVELOPMENT AUTHORITY

(hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of Four thousand four hundred one and no/100-----

-----Dollars (\$4,401.00) due and payable in 180 consecutive monthly installments of Thirty and 41/100 (\$30.41) Dollars, due and payable on the 15th day of each month, commencing on January 15, 1982,

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, at the intersection of Johnson Avenue and Campbell Avenue, in the City of Greer, being known and designated as Lot No. 3 on a plat entitled "Property of John Donaldson" recorded in the R.M.C. Office for Greenville County, South Carolina in Plat Book 00 at Page 155, reference to said plat is hereby made for a more complete description thereof, said lot being 60 x 140 x 60 x 140.
