### MORTGAGE

THIS MORTGAGE is made this 11th day of DECEMBER, 1981, between the Mortgagor, C. DAN JOYNER AND CHARLES E. UPCHURCH, (herein "Borrower"), and the Mortgagee, First Federal Savings and Loan Association, a corporation organized and existing under the laws of the United States of America, whose address is 301 College Street, Greenville, South Carolina (herein "Lender").

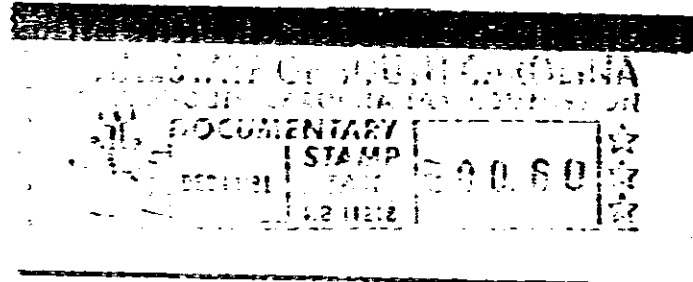

TO SECURE to Lender (a) the repayment of the indebtedness evidenced by the Note, with interest thereon, the payment of all other sums, with interest thereon, advanced in accordance herewith to protect the security of this Mortgage, and the performance of the covenants and agreements of Borrower herein contained, and (b) the repayment of any future advances, with interest thereon, made to Borrower by Lender pursuant to paragraph 21 hereof (herein "Future Advances"), Borrower does hereby mortgage, grant and convey to Lender and Lender's successors and assigns the following described property located in the County of GREENVILLE, State of South Carolina:

ALL that certain piece, parcel or lot of land situate, lying and being in the City and County of Greenville, State of South Carolina and being shown and designated as Lot No. 5 on a Plat of property of Roy J. Meaders recorded in the R.M.C. Office for Greenville County, South Carolina in Plat Book "UU" at Page 79 B and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at a point on Biltmore Avenue at the joint front corner of Lots Nos. 4 and 5 and running thence with Biltmore Avenue S. 9-10 W. 65 feet to a point; thence running N. 79-50 W. 166.6 feet to a point; thence running N. 8-31 E. 56.1 feet to a point; thence running S. 82-54 E. 167.4 feet to the point of beginning.
