Greenville, South Carolina, hereinafter called the Mortgagor, send(s) greetings:

WHEREAS, the Mortgagor is well and truly indebted unto The Kissell Company

organized and existing under the laws of the State of Ohio, hereinafter called the Mortgagee, as evidenced by a certain promissory note of even date herewith, the terms of which are incorporated herein by reference, in the principal sum of Fifty Thousand and No/100 Dollars (\$ 50,000.00).

All that certain piece, parcel or lot of land situate, lying and being in the State of South Carolina, County of Greenville and being described as follows:

BEGINNING at a point on the southeast side of Taylors Bridge Road, joint front corner with property owned by Shanbhag and Vakharia and running thence S. 58-14 E. 71.86 feet to an iron pin; thence S. 35-57 E. 47.12 feet to an iron pin; thence S. 51-12 W. 33.9 feet to an iron pin; thence S. 48-06 W. 73 feet to an iron pin; thence S. 48-06 W. 20 feet to a nail and bottle cap in center of Taylors Bridge Road; thence N. 10-22 W. 113.55 feet to a railroad spike in center of said road; thence N. 27-30 E. 42 feet to point of beginning.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and equipment now or hereafter attached to or used in connection with the real estate herein described.

TO HAVE AND TO HOLD, all and singular the said premises unto the Mortgagee, its successors and assigns forever. The Mortgagor covenants that he is lawfully seized of the premises hereinabove described in fee simple absolute, that he has good right and lawful authority to sell, convey, or encumber the same, and that the premises are free and clear of all liens and encumbrances whatsoever.
