"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of GREENVILLE, being known and designated as Lot No. 2 of Block E of a subdivision known as Washington Heights, according to a plat thereof prepared by N. O. McDowell, Jr. and Julian P. Moore, Surveyors, recorded in the R.M.C. Office for Greenville County in Plat Book M at Page 107, and having such metes and bounds, courses and distances as shown on said plat, reference thereunto being had for a more complete description of said property.
