NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, the Mortgagee's heirs, successors and assigns:

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville

All that certain piece, parcel or lot of land situate, lying and being in Ward 5 of the City of Greenville, State of South Carolina, on the north side of Pendleton Street, and having according to a plat prepared by C.M. Furman, Jr., Engineer, October 6, 1925, the following metes and bounds, to-wit:

Beginning at an iron pin on the north side of Pendleton Street, which pin is 189 feet west from the northwest intersection of Pendleton and Markley Street, and running thence along line of Wm. Hoesh property N. 18-20 W. 278.5 feet to an iron pin on the south side of Rhett Street; thence along said street N. 70-30 E. 89 feet to an iron pin; thence S. 18-20 E. 278.5 feet to an iron pin on the northern side of Pendleton Street; thence along said Pendleton Street S. 70-30 W. 89 feet to the point of beginning.

ALSO:

All that piece, parcel or lot of land in Greenville County, State of South Carolina, at the southwest corner of Rhett and Markley Street and running thence along the southern side of Rhett Street S. 70-30 W. 100 feet to an iron pin on corner of other property of J. Robert Martin; thence S. 18-20 E. 128.6 feet to an iron pin; corner of church property; thence along the line of church property N. 70-30 E. 100 feet to iron pin on the west side of Markley Street N. 18-20 W. 128.6 feet to the point of beginning.
