ALL that piece, parcel or lot of land with buildings and improvements, situate, lying and being on the Eastern side of Helen Drive in Gantt Township, Greenville County, South Carolina, being shown and designated at Lot No. 173 on a plat of Rockvale, Sec. 2, made by J. Each of the undersigned agrees that no extension of time or other variation of any obligation secured by this mortgage will affect any other obligations under this mortgage.

Each of the undersigned waives marital rights, homestead exemption and all other exemptions under South Carolina law.

This mortgage will extend, consolidate and renew any existing mortgage you hold against me on the real estate described above.
