NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt and for better securing the payment thereof to the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell, and release unto the Mortgagee, its successors and assigns, the following-described real estate situated in the County of Greenville

State of South Carolina:

All that certain piece, parcel or lot of land situate, lying and being on the Southwestern side of Heather Way, in the City of Greenville, County of Greenville, State of South Carolina, being known and designated as Lots Nos. 120, 121 and 122 as shown on a plat entitled "Marshall Forest", dated October, 1928, prepared by Dalton & Neves, recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book H at page 134, and having, according to a more recent plat entitled "Property of Eileen Delasandro", dated January 11, 1982, prepared by Freeland & Associates, and recorded in said R.M.C. Office in Plat Book 8-X at page 57, the following metes and bounds:

BEGINNING at an iron pin on the Southwestern side of Heather Way at the joint front corner of Lots Nos. 122 and 123, and running thence with the line of Lot No. 123 S. 33-23 W. 201.10 feet to an iron pin in the line of a ten foot alley reserved for pipes and poles; thence with the line of said alley N. 39-57 W. 80.35 feet to an iron pin at the joint rear corner of Lots Nos. 119 and 120; thence with the line of Lot No. 119 N. 34-05 E. 178.83 feet to an iron pin on the Southwestern side of Heather Way; thence with the Southwestern side of Heather Way S. 56-02 E. 74.81 feet to the point of beginning.

This is the identical property conveyed to the Mortgagor herein by deed of Raymond P. Morgan and Susan G. Morgan, dated January 20, 1982, and recorded in the R.M.C. Office for Greenville County in Deed Book 1161 at page 251, on January 20, 1982.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and equipment now or hereafter attached to or used in connection with the real estate herein described.

TO HAVE AND TO HOLD, all and singular the said premises unto the Mortgagee, its successors and assigns forever.

The Mortgagor covenants that he is lawfully seized of the premises hereinabove described in fee simple absolute, that he has good right and lawful authority to sell, convey, or encumber the same, and that the premises are free and clear of all liens and encumbrances whatsoever. The Mortgagor further covenants to warrant and forever defend all and singular the premises unto the Mortgagee forever, from and against the Mortgagor and all persons whomsoever lawfully claiming the same or any part thereof.

The Mortgagor covenants and agrees as follows:

1. That he will promptly pay the principal of an interest on the indebtedness evidenced by the said note, at the times and in the manner herein provided. Privilege is reserved to pay the debt in whole, or in an amount equal to one or more monthly payments on the principal that are next due on the note, on the first day of any month prior to maturity; provided, however, that written notice of an intention to exercise such privilege is given at least thirty (30) days prior to prepayment.
