All that piece, parcel, or lot of land, situate, lying and being in the State of South Carolina, County of Greenville, on the northwestern side of Graceland Street, being known and designated as Lot No. 19 according to a plat of said property prepared by C.M. Furman, Jr., Engineer, October 1924, being recorded in the R.M.C. Office for Greenville County in Plat Book G at Page 14, and having to a plat prepared by Pickell & Pickell Engineers, dated September 18, 1946, the following metes and bounds, to-wit:

BEGINNING at a stake 200 feet from Pendleton Road at the corner of Lot No. 18 and running thence N 82-30 W 73.7 feet to a stake; thence N 50-00 E 63.9 feet to a stake at the rear corner of Lot No 20, thence with the line of lot 20 S 58-05 E 202 feet to a stake on the northwestern side of Graceland Street, thence with Graceland Street S 31-55 W 50 feet to the beginning corner, and being the same property conveyed to Lloyd Edwin Woodall by Central Realty Corporation by deed dated May 20, 1947 and recorded in the R.M.C. I will pay all taxes, liens, assessments, obligations, encumbrances and any other charges against the real estate and maintain insurance on the real estate in your favor in a form and amount satisfactory to you.
