Whereas, I the said John T. Johnson

in and by my certain promissory

note in writing, of even date with

these presents, am well and truly indebted to Southern Bank and Trust
Company of Williamston, South Carolina

in the full and just sum of Four Thousand Fifty-One and 80/100 (\$4,051.80)

Dollars to be paid in Thirty-Six (36) equal installments in the
sum of One Hundred Twelve and 55/100 (\$112.55) Dollars each,
beginning March 15, 1982, and a like installment being due and payable
on the 15th day of each and every calendar month thereafter until
paid in full.

with interest thereon from date
