The words "you" and "your" refer to Mortgagee. The words "I," "me" and "my" refer to all Mortgagors indebted on the note secured by this mortgage.

To secure payment of a note which I signed today promising to pay you the above Total of Payments and to secure all my other and future obligations to you, the Maximum Outstanding at any given time not to exceed the amount stated above, each of the undersigned grants, bargains, sells and releases to you the real estate described below and all present and future improvements on the real estate, which is located in South Carolina, County of Greenville

ALL that certain piece, parcel or tract of land situate, lying and being in Grove Township, Greenville County, State of South Carolina, being known and designated as Lot No. 2 and having 1.63 acres, more or less, according to a plat of property of L. W. Young prepared by C. O. Riddle dated April 1955, recorded in Plat Book 11, page 119 in the RMC Office for Greenville County and having according to said plat the following metes and bounds, to wit: Beginning at a point in the center line of said road and running thence S. 36 E. 269.4 feet to an iron pin; thence, N. 83-24 E. 258.4 feet to an iron pin thence N. 6-36 W. 275.2 feet to a point in the center of line of said Piedmont Bessie Highway; thence along the center of said highway S. 83-24 W. 189.7 feet to a point; thence continuing along the center of said highway S. 78-58 W. 68.9 feet to the point of beginning.

If I pay the note secured by this mortgage according to its terms this mortgage will become null and void.

If I do not eliminate the default in the manner stated in the notice, or if I eliminate the default after you send the notice but default on a future payment by failing to pay on schedule, or if my ability to repay my loan or the condition, value or protection of your rights in the collateral securing my loan is significantly impaired, then the full amount I owe, less any charges which you have not yet earned, will become due, if you desire, without your advising me.

I will pay all expenses you incur in enforcing any security interest, including reasonable attorney's fees as permitted by law.

Each of the undersigned agrees that no extension of time or other variation of any obligation secured by this mortgage will affect any other obligations under this mortgage.

Each of the undersigned waives marital rights, homestead exemption and all other exemptions under South Carolina law.

This mortgage will extend, consolidate and renew any existing mortgage you hold against me on the real estate described above.

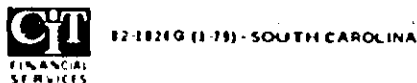
