To secure payment of a note which I signed today promising to pay you the above Total of Payments and to secure all my other and future obligations to you, the Maximum Outstanding at any given time not to exceed the amount stated above, each of the undersigned grants, bargains, sells and releases to you the real estate described below and all present and future improvements on the real estate, which is located in South Carolina, County of Greenville.

All that lot of land in the county of Greenville, state of South Carolina, known and designated as Lot No. 48 on plat of Section 2, Coachman Estates, made by Campbell & Clarkson, Surveyors, Inc. February 4, 1972, and having according to said plat the following metes and bounds, courses and distances, to-wit:

Beginning at an iron pin on the east side of Carriage Drive, the joint front corner of Lots 48 & 49; thence with the joint line of said lots S. 87-00 E. 150 feet to an iron pin; thence N. 3-00 E. 244.8 feet to an iron pin corner of Lot No. 47; thence with the line of said lot S. 42-36 W. 254.8 feet to an iron pin on the east side of Carriage Drive; thence with the curve of said street S. 11-28 E. 50 feet to the beginning corner.

I will pay all expenses you incur in enforcing any security interest, including reasonable attorney's fees as permitted by law.

Each of the undersigned agrees that no extension of time or other variation of any obligation secured by this mortgage will affect any other obligations under this mortgage.

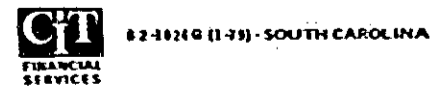
Each of the undersigned waives marital rights, homestead exemption and all other exemptions under South Carolina law.
