TO ALL WHOM THESE PRESENTS MAY CONCERN:

SEND GREETINGS:

Whereas, I, we the said Edwin Harry Markham and Maryanne E. Markham, hereinafter called Mortgagor, in and by my, our certain note or obligation bearing even date herewith, stand indebted, firmly held and bound unto the Citizens and Southern National Bank of South Carolina, Greenville, S. C., hereinafter called Mortgagee, the sum of \$4,605.88 plus interest as stated in the note or obligation, being due and payable in 60 equal monthly installments commencing on the last day of April, 1982, and on the same date of each successive month thereafter.

Said note provides that past due principal and/or interest shall bear interest at the rate of seven (7%) per cent per annum as reference being had to said note will more fully appear; default in any payment of either principal or interest to render the whole debt due at the option of the Mortgagee or holder hereof. All that certain piece, parcel or lot of land and the improvements thereon, situate, lying and being in the State of SC, County of Greenville, and being known and designated as Lot 29 on a Plat of Buxton recorded in Plat Book 4-N at page 2, RMC Office, Greenville County, SC, and having, according to said plat the following metes and bounds, to-wit:

BEGINNING at a point on Bexhill Court at the joint front corner of Lots Nos 29 & 30, and running thence with said common line N 52-50 W 162.5 ft. to a point; thence running N. 39-19 E. 120.0 ft. to a point; thence running S 52-45 E 160.0 ft. to a point; thence running with Bexhill Court S 38-19 W 61.4 ft. to a point; thence continuing S 36-14 W 58.6 ft. to the point of beginning.
