To secure payment of a note which I signed today promising to pay you the above Total of Payments and to secure all my other and future obligations to you, the Maximum Outstanding at any given time not to exceed the amount stated above, each of the undersigned grants, bargains, sells and releases to you the real estate described below and all present and future improvements on the real estate, which is located in South Carolina, County of Greenville.

ALL that piece, parcel or lot of land situate, lying and being in the County of Greenville, state of South Carolina, on the Northwest side of Mill Street, being known as Lot 81 on plat of Abney Mills, Renfrew Plant at Travelers Rest, shown on plat of Dalton & Neves recorded in the R.M.C. Office for Greenville County in Plat Book "QQ", at page 53, and having, according to said plat, the following metes and bounds, to wit:

BEGINNING at an iron pin on the Northwest side of Mill Street at the joint Front corner of Lots 80 and 81 and runs thence along Mill Street N. 38-03 E. 91 feet to an iron pin; thence along the line of Lot 81 N. 50-56 W. 183.1 feet to an iron pin; thence S. 39-15 W. 80 feet to an iron pin; thence along the common line of Lots 80 and 81 S. 47-28 E. 185 feet to an iron pin on the Northwest side of Mill Street, the beginning corner.

If I pay the note secured by this mortgage according to its terms this mortgage will become null and void.

I will pay all expenses you incur in enforcing any security interest, including reasonable attorney's fees as permitted by law.

Each of the undersigned agrees that no extension of time or other variation of any obligation secured by this mortgage will affect any other obligations under this mortgage.

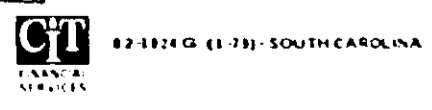
Each of the undersigned waives marital rights, homestead exemption and all other exemptions under South Carolina law.
