MORTGAGE OF REAL PROPERTY

NOW, THEREFORE, in consideration of the aforesaid loan and the sum of Three Dollars (\$3.00) cash in hand paid to Mortgagor, the receipt of which is hereby acknowledged, Mortgagor hereby grants, sells, conveys, assigns and releases to Mortgagee, its successors and assigns, the following described premises located in Greenville _ County, South Carolina:

ALL that certain piece, parcel or lot of land, with all improvements thereon, situate, lying and being in the State of South Carolina, County of Greenville, Chick Springs Township, on the western side of Havenhurst Drive, being known and designated as Lot 85 as shown on a plat of Section II, Homestead Acres, plat dated April 26, 1963 by Piedmont Engineering Service and recorded in the RMC Office for Greenville County, South Carolina in Plat Book XX, at Page 143, reference to which plat is hereby craved for a metes and bounds description.

This is the same property conveyed to the mortgagors herein by deed of J. James Brady and Patricia C. Brady recorded in the RMC Office for Greenville County in Deed Book 1069 at Page 48 dated November 23, 1977.

This mortgage is second and junior in lien to that mortgage given in favor of Cameron Brown Company which mortgage was recorded in the RMC Office for Greenville County in Mortgages Book 1416 at Page 837 in the original amount of \$37,000.00.
