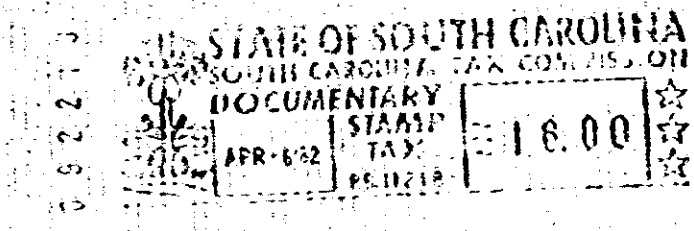
with interest thereon from *M.P.* date at the rate of 15-1/2% per centum per annum, to be paid: monthly
