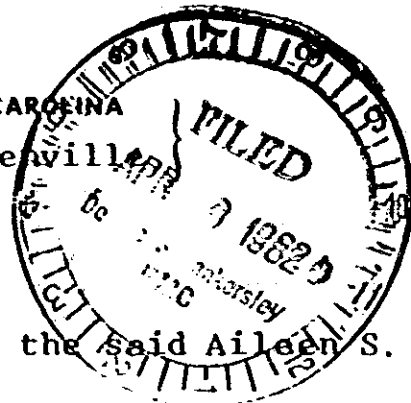

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"All that certain piece, parcel or lot of land situate, lying and being near the City of Greenville, in the County of Greenville, State of South Carolina, being known and designated as Lot No. 18, Section E, as shown on a plat prepared by N. O. McDowell, Jr. and Julian P. Moore, dated December, 1944, entitles "Washington Heights", recorded in the RMC Office for Greenville County, South Carolina, in Plat Book M At Page 107, and having such metes and bounds as is shown thereon."

This is the identical property conveyed to Aileen Riley by Violet M. Stallings by deed recorded in Deed Book 628, at page 450 in the RMC Office for Greenville County on June 30, 1959.
