MORTGAGE (Construction)

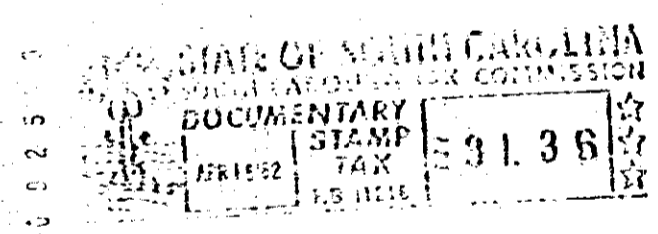
THIS MORTGAGE is made this fifteenth day of April, 1982, between the Mortgagor, Danco, Inc., (herein "Borrower"), and the Mortgagee, South Carolina Federal Savings and Loan Association, a corporation organized and existing under the laws of the United States of America, whose address is 1500 Hampton Street, Columbia, South Carolina (herein "Lender").

WHEREAS, Borrower is indebted to Lender in the principal sum of Seventy-eight thousand four hundred and no/100ths (\$78,400) Dollars or so much thereof as may be advanced, which indebtedness is evidenced by Borrower's note dated April 10, 1981, (herein "Note"), providing for monthly installments of interest, with the principal indebtedness, if not sooner paid, due and payable on October 1, 1982.

TO SECURE to Lender (a) the repayment of the indebtedness evidenced by the Note, with interest thereon, the payment of all other sums, with interest thereon, advanced in accordance herewith to protect the security of this Mortgage and the performance of the covenants and agreements of Borrower herein contained, (b) the performance of the covenants and agreements of Borrower contained in a Construction Loan Agreement between Lender and Borrower dated April 10, 1981, 1981, (herein "Loan Agreement") as provided in paragraph 20 hereof, and (c) the repayment of any future advances, with interest thereon, made to Borrower by Lender pursuant to paragraph 17 hereof (herein "Future Advances"), Borrower does hereby mortgage, grant, and convey to Lender and Lender's successors and assigns the following described property located in the County of Greenville, State of South Carolina:

ALL that piece, parcel or lot of land situate, lying and being in the County of Greenville, State of South Carolina, being within the corporate limits of the Town of Mauldin and being known as Lot 67 of plat of Forrester Woods Subdivision Section 7, said plat being recorded in the RMC Office for Greenville County in Plat Book 5 P at Pages 21 and 22 and being also shown on a plat of Property of Danco, Inc. by R. B. Bruce, Surveyor dated April 13, 1982 and having the metes and bounds as shown on said later plat.

This is the same property conveyed to the mortgagor herein by deed of W. D. Yarborough recorded May 11, 1978, in Deed Book 1078 at Page 982.

Borrower covenants that Borrower is lawfully seized of the estate hereby conveyed and has the right to mortgage, grant, and convey the Property, that the Property is unencumbered, and that Borrower will warrant and defend generally the title to the Property against all claims and demand, subject to any declarations, easements, or restrictions listed in a schedule of exceptions to coverage in any title insurance policy insuring Lender's interest in the Property.
