"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, primarily, but partially in the County of Spartanburg, S.C., near Pelham, S.C., on the western side of the Greer-Pelham Road (Old Highway No. 14) and having, according to a plat prepared by Webb Surveying & Mapping Co., dated November, 1979, which plat is recorded in the RMC Office for Greenville County, S.C., in Plat Book 7-Q at Page 70, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the western side of Old Highway No. 14 and running thence with the right-of-way of said road S. 31-30 W. 50 feet to an iron pin; thence with the joint line of property now or formerly belonging to Davis N. 58-45 W. 200 feet to an iron pin; thence continuing N. 73-14 W. 333.22 feet to an iron pin in the creek which is the line; thence N. 31-52 E. 48.6 feet to an iron pin in the creek; thence S. 73-14 E. 327.02 feet to an iron pin; thence S. 59-35 E. 205.7 feet to an iron pin, the point of beginning.
