Each of the undersigned waives marital rights, homestead exemption and all other exemptions under South Carolina law.

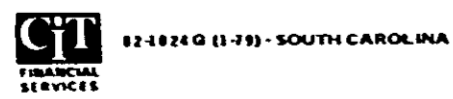
