ACCORDING TO TERMS SET OUT IN SAID NOTE.

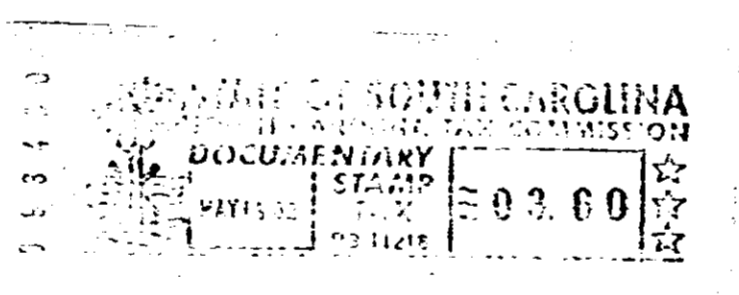

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in the City of Mauldin, being shown and designated as Lot No. 22 on a plat entitled "Rustic Estates" dated April 16, 1974, by Piedmont Engineers-Architects-Planners and recorded in the RMC Office for Greenville County in Plat Book 4-R at Page 71 and having, according to a new plat prepared by Richard D. Wooten, Jr., dated April 21, 1980, recorded in said RMC Office in Plat Book 7-Z at Page 35, such metes and bounds as are more fully shown thereon.
