MORTGAGE

THIS MORTGAGE is made this 24th day of May, 1982, between the Mortgagor, Nelson & Putman Builders, Inc., (herein "Borrower"), and the Mortgagee, First Federal Savings and Loan Association of South Carolina, a corporation organized and existing under the laws of the United States of America, whose address is 301 College Street, Greenville, South Carolina (herein "Lender").

WHEREAS, Borrower is indebted to Lender in the principal sum of Seventy-five Thousand Fifty and No/100 Dollars, which indebtedness is evidenced by Borrower's note dated May 24, 1982, (herein "Note"), providing for monthly installments of principal and interest, with the balance of the indebtedness, if not sooner paid, due and payable on May 1, 2013.....;
