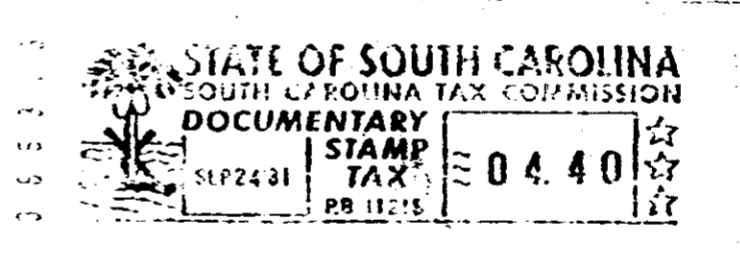

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of GREENVILLE, lying and being in the Woodside Mills Village in the town of Fountain Inn, and being more particularly described as Lot No. 63 as shown on a plat entitled "A Subdivision of Woodside Mills, Fountain Inn, S. C." made by Piedmont Engineers, Greenville, South Carolina, on October, 1952 and recorded in the Office of the R. M. C. for Greenville County in Plat Book BB at Page 83. According to said plat, the within described lot is also known as No. 6 Church Street (a/k/a 204 Woodside Avenue) and fronts thereon 52 feet.

DERIVATION: This being the same property conveyed to the mortgagor herein by virtue of a deed from Woodside Mills recorded in Deed Book 468 at Page 441 on December 17, 1952.
