WHEREAS, RICHARD J. PENDINO AND DEBORAH TRELLE PENDINO

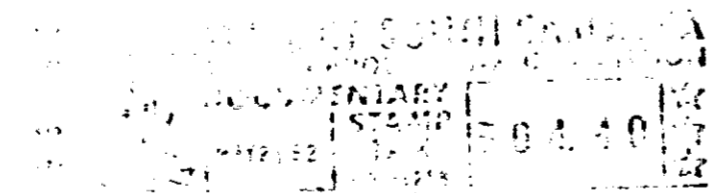

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in or near the town of Simpsonville, shown as lot 145 on a plat of Woodside Mill Village, recorded in the R.M.C. Office for Greenville County in Plat Book GG at page 5, to which plat reference is hereby made for a more particular description. According to said plat, the within described lot is also known as lot 13, Fourth Street and fronts thereon 79 feet.
