"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Austin Township, City of Mauldin, as recorded in the RMS Office for Greenville County in Plat Book YY at Pages 118 and 119 on plat of Eastdale Development as Lot 133, Eastdale, also described as 307 Drury Lane, Mauldin.
