WHEREAS, JAMES R. BRYSON and SHEILA B. BRYSON

(hereinafter referred to as Mortgagor) is well and truly indebted unto
HAZEL D. EDWARDS,

(hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of

SEVENTEEN THOUSAND AND NO/100ths Dollars (\$ 17,000.00) due and payable in 59 monthly installments of \$301.17 each beginning 30 days from date and the full balance due 60 months from date. Monthly payments shall be applied first to interest, balance to principal. Borrowers may make additional payments to principal not in excess \$8,000.00 during 1983, without penalty and after 1983, borrowers may anticipate in full without penalty with interest thereon from date at the rate of 12.00 per centum per annum, to be paid: as aforesaid

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purposes:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in the City of Greer, consisting of all of Lot 41 and 42 and the major portion of Lot 43 as shown on a plat entitled, "Map of Morrow Park" recorded in Plat Book E at page 91 and being more particularly described in accordance with a plat entitled, "Property of James R. and Sheila B. Bryson", prepared by John A. Simmons, Surveyor, dated May 28, 1982 to be recorded of even date herewith. The subject property fronts on the easterly side of Memorial Drive a total distance of 84.85 feet.

THIS is the identical property conveyed to the Mortgagors by deed of the mortgagee to be recorded of even date herewith and this mortgage is being given to secure a portion of the purchase price of the within described property.

It is hereby agreed that any payment not received within fifteen days of due date shall be subject to a late payment penalty of 5% of the payment amount.

It is further agreed and understood that this mortgage and the note it secures, shall become immediately due and payable if the subject property is transferred by deed or contract without the prior written consent of the mortgagee.
