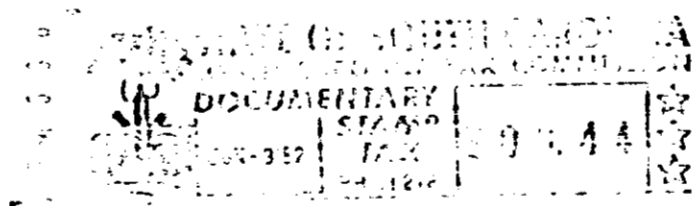
NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, the Mortgagee's heirs, successors and assigns:

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville.

ALL that certain piece, parcel or lot of land situate, lying and being in the County of Greenville, State of South Carolina, in Bates Township, containing 0.06 acres, more or less, and having the following metes and bounds, to-wit:

BEGINNING at an iron pipe on Ben Redmon's line and on the western bank of a Greenville County Road that leads north into the Bellevue Road and about one mile southwest from Bellevue crossroads and running thence with Redmon's line, N.41-00 W. 200 feet to an iron pipe; thence S.14-20 W. 150 feet to an iron pipe at Dogwood; thence S.41-00 E. 200 feet to an iron pipe on bank of County Road; thence N.14-20 E. 150 feet to the beginning corner.
