"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville.

ALL that certain piece, parcel or lot of land situate, lying and being in the County of Greenville, State of South Carolina, being known and designated as Lot No. 1, BLUE RIDGE HEIGHTS Subdivision according to a plat prepared of said property by Thurl M. Amick, Registered Surveyor, dated October 10, 1975, revised April 23, 1976, and which plat is recorded in the RMC Office for Greenville County in Plat Book 5-P at Page 27 and having such metes and bounds as shown thereon, reference to said plat being made for a more complete description.
