TO ALL WHOM THESE PRESENTS MAY CONCERN: SLEY

I, LOIS H. HOLDER, (hereinafter referred to as Mortgagor) SEND (S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto NATIONWIDE INSURANCE COMPANY (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of

All that Piece, parcel or lot of land, situate, lying and being in the State of South Carolina, County of Greenville, and being known and designated as Lot No. 24 on a plat of Section I, Tanglewood, recorded in Plat book GG at page 57 and having, according to said plat, the following metes and bounds, to-wit:
