NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the Southern side of South Fairfield Road and containing 1.259 acres, more or less, as shown upon survey and plat made for Willie H. Maddox by Webb Surveying and Mapping Company dated June 1979, and recorded in Plat Book 7-H at Page 48, in the RMC Office for Greenville County and having according to said plat the following metes and bounds, to-wit:

BEGINNING at a spike in the middle of South Fairfield Road, said spike being 2,447 feet from Augusta Road, and running thence S. 24-20 W. 314.42 feet to an iron pin; thence N. 52-56 W. 194.16 feet to an iron pin; thence N. 24-11 E. 274.19 feet to a spike in the center of South Fairfield Road; thence running along the center of South Fairfield Road S. 60-06 E. 118.09 feet to a spike; thence continuing along the center of said South Fairfield Road S. 71-56 E. 74.47 feet to a spike, the point of beginning.
